Customer hereby acknowledges and agrees that it has the custody, care, and control of the equipment owned by Dump It Sanitation & Recycling, Inc., and accepts responsibility for said equipment and its contents while on customer's property in their custody, care, and control. Customer agrees to indemnify and hold harmless Dump It Sanitation & Recycling, Inc., from and against any and all claims actions and suits, whether groundless or otherwise, from and against any and all liabilities, losses, damages, costs, charges, attorney fees, and other expenses of every nature and character which they may at any time sustain or incur by reason of any claim or demand which may be made resulting from or arising in any manner of customer's use, operation, or possession of any equipment furnished under this agreement, whether or not such losses, damages, costs, charges, attorney fees, and other expenses arise or occur through accident, oversight, inadvertence, or negligence on the part of Dump It Sanitation & Recycling, Inc., its officers, agents, or employees.

Customer acknowledges that Dump It Sanitation & Recycling, Inc., employees may drive company vehicles/equipment on customer's property and accepts responsibility for any and all damage that may occur from or by Dump It Sanitation & Recycling, Inc.'s, vehicles/equipment. Customer acknowledges that Dump It Sanitation & Recycling, Inc.'s trucks are heavy especially when loaded and Dump It Sanitation & Recycling, Inc. is not responsible for damage caused by said trucks. This includes but is not limited to damage to roads, culverts, fences, landscaping, sidewalks, sprinkler systems, grass, trees, and bushes or other areas that the vehicle/equipment may contact while attempting to service said container.

Further, customer will warrant that all waste placed in the container is of a non-hazardous nature and that the following are not acceptable in the roll-off/dumpster...

**Wastes determined to be hazardous by Iowa Administrative Code, sewage sludge, including un-stabilized septic tank pumping, industrial waste not approved for acceptance by the IDNR, infectious waste, unless approved by the IDNR, asbestos, acids, poisons, caustics, pesticides, herbicides, used oil or used oil filters including gas cans, radioactive wastes, free liquids or wastes containing free liquids, animal manure or dead animals, wastes containing polychlorinated biphenyls (PCBs), waste that could spontaneously combust or could ignite other wastes due to temperatures, tires, lead acid batteries, nickel-cadmium batteries, trees or yard waste, motorized vehicles, machinery, wire, large rocks or concrete, major household appliances, paint products, explosives, electronics such as computers, monitors, copy machines, fax machines, TVs etc., florescent bulbs.**

All **dumpster** lids shall be closed upon servicing and no contents may be above the top of the dumpster. Any contents above the top of the container may result in additional fees and/or be unable to be serviced until customer fixes said problem.

All contents in the **roll-off** must fit inside the roll-off and must not be above the fill line. **NO ITEMS LONGER THAN 6 FEET!!** Daily rental rates will continue to be incurred until which time as the container is able to be tarped for transport. Any overweight or improperly loaded roll-offs are subject to additional fees.
